## Fabric:

The Company warrants Sauder Program Fabrics, if purchased through Sauder for use on Sauder products for a period of 5 years.

Company has assembled an extensive graded-in offering featuring a wide selection of upholstery selected for performance. Sauder Program fabrics are available through Architex, Arc-com, C.F. Stinson, Maharam, Mayer, and Momentum. Company warrants these textiles to perform under normal conditions as furniture upholstery and when cared for according to cleaning and maintenance guidelines provided by the textile supplier. Proper care and cleaning is imperative for maximizing textile performance. However, in the unlikely event that one of these upholsteries does not perform in accordance with manufacturing specifications when used and maintained under normal conditions, and the user has not misused, cleaned or attempted to clean using cleaning agents or procedures not suggested or approved by the textile supplier, Company will replace the fabric or like fabric free of charge.

## Exclusions:

The following are specially excluded from the warranty:

- Any custom components that are not a part of the Company standard line. This would include, but not be limited to, custom-designed parts or customer specified components, such as fabric, vinyl, foam, etc., that are not a part of the standard Company product line.
- Accessories such as light bulbs that are considered consumables.
- Furniture that has been unduly exposed to the elements such as water, light radiation, etc.
- Damage caused in storing/moving products or furniture after delivery and prior to installation – when stored at customer request.
- Damage caused by on-site construction process, other contractors or

subcontractors, or the work of such contractors or subcontractors, including drywall dust.

- Damage as the result of accident, fire, flood, civil disorder, strike, Acts of God, abuse, misuse or any cause outside of ordinary usage.
- Normal wear and tear, maintenance, scratching or natural wearing of finishes on chairs and tables.
- Any responsibility for the effects the chairs have on flooring.
- Fixed Seating:
  - Not installed by Company or Company authorized personnel
  - Loose floor anchors caused by flooring not being to standard
  - Damage to on-site flooring, i.e. buckling, peeling, lifting, shifting or sliding due to substandard flooring installations
  - If moved from original anchored locations, unless moved by authorized personnel
  - Damage to the product as a result of inferior or damaged flooring surface
- Damage caused from shipping.

## General Information:

- We have agreements with our upholstery suppliers to assure that all products meet Association of Contract Textiles standards for bow and skew. We also further eliminate pattern variability in our cutting process. However, you may still notice some irregularities that are within industry standards and are not covered under our product warranty.
- Replacement, repair, or refund of the purchase price, (pro-rated for use), as determined by Company and is the "sole and exclusive" remedy under the warranty, and all incidental and consequential damages are excluded

1. Notify the Company of the defect.
2. Fill out the Company service request form, which will be sent to you, and provide a description of the defect.
3. Submit completed form along with applicable photos.

D. Any disputes over the provisions of this warranty will be mutually reviewed by representatives of Purchaser and Company.
